According to our records your International Certificate of Competence (ICC) is due for renewal. In order to renew your ICC you must still be eligible for the RYA to issue the certificate to you.

****IMPORTANT - Following changes to the eligibility criteria, proof of eligibility is now required from <u>every</u> applicant.

The requirements are detailed on the renewal form overleaf in section 1. ****

If you chose to renew your ICC, your new certificate, valid for a further 5 years, will be issued with the same categories validated as your existing certificate. The only exception to this is for certificates issued prior to 1st April 1999, where the inland category will not be re-validated unless we have proof that the holder has passed the CEVNI test. Should you require any further categories validated you will need to pass the appropriate ICC assessment or provide the documentary evidence of competence detailed in the table below.

If you wish to renew your ICC then please complete and return the form on the reverse of this letter and send it together with your old certificate (if possible), a passport-sized photograph (ensuring you print your name on the back of the photo), proof of eligibility and the fee as applicable to your membership status.

Please allow 21 days for your new certificate to be issued. Fast Track Service - for a small additional charge we can guarantee a 2 working day turnaround from the date we receive the application. If you require this service, please clearly mark your application with "FAST TRACK" and include the applicable additional fee (as detailed on the form).
